**C 1-158 IN 28 January 2024 AAR****Summary**

On 28 January 2024 at 0531L T22 was attacked by an OWUAS. This report is not an assessment of the attack, it is an After-Action Review of T22's response to the attack. There was no advanced warning from any radar or other system on T22 or ATG. The OWUAS struck a six-man housing unit, completely destroying the housing unit and severely damaging the surrounding housing units. Personnel around the impacted housing unit responded to the site and started extraction, treatment and transportation of the casualties. The SECFOR BDOC identified the point of impact and directed QRF, EOD, Aid and Litter Teams to the site. Aid and Litter teams were able to extract casualties from under rubble and one from the roof of an adjoining housing unit and transport them to the triage location. Medical personnel responded to designated locations and started treatment and evacuation. Three personnel were deceased and three more were designated as urgent and were evacuated within several hours. Six more patients were identified as needing evacuation and were transported via air several hours later. Over 12 personnel were ground evacuated the following day after further screening for TBI. Screening and medical evaluation is still on going for remaining personnel.

**Preparation Phase**

Preparation phase started when units arrived on ground at T22 and ended before the attack. During this phase SOPs were built and revised during four battle drill rehearsals. Equipment was staged and prepared during this phase. CCPs were identified and stocked with medical supplies.

**Sustainment:**

Observation: Prior battle drill and MASCAL rehearsals were beneficial in responding to the attack.

Discussion: T22 conducted four IDF/OWUAS attack and React to Casualty Drills since November 2023, the last occurring on 25 January 2024, three days prior to the attack. The rehearsal on 25 January 2024 was conducted at night with full base participation. It included 8 simulated casualties with moulage kits. The rehearsal also included simulated attack, QRF, EOD, Air Force PJ and Aid and Litter team response, casualty evacuation, triage, treatment and loading of casualties onto medivac aircraft.

Recommendations: [REDACTED]

Follow up/Tasking:

**SECFOR: Plan and prepare for next rehearsal.**

**Improvements needed:**

Observation: Information needed for medical reporting was not available for all units on base. This included DODID, Battle Roster Number, blood type.

Discussion: Due to critical information being unavailable medical documentation was incomplete, inaccurate or difficult to complete. Information for drawing blood in the event it was needed was not available for all SMs on post.

Follow up/Tasking:

Mayors cell provide a check in procedure that includes gathering all critical information as well as providing an orientation briefing. This orientation briefing should include check in with the BDOC to review Battle Drills and prowords, TMC to CAC into medical system, fill out TCCC, confirm medical information and a tour of the immediate area to point out CCPs, bunkers and triage location.

ASG-J: A map with CCP locations and bunkers should also be provided to new comers and be posted in all available secret areas.

Observation: Base could have been hardened or re enforced

Discussion: T22 could be hardened in a number of ways and bunker space is limited. Kinetic assets are needed.

Follow up/Tasking

ASG-J: Plan and emplace T walls and hesco barriers. Place clear laminate on windows. Designate sand bag wall locations. Secure coyote system.

T22 Personnel: Fill one sand bag prior to entering chow hall

SECFOR: Plan bunker rehearsal with accommodation evaluation

### Notification Phase

Notification Phase started after the attack took place and ended once no more threats were present and an "All Clear" was given. During this attack there was no advanced warning from any system on T22 or ATG.

### **Improvements Needed:**

Observation: Communication was not adequate for base alerts and prowwords

Discussion: The LRAD system was difficult to hear or was not heard in certain areas of T22. Because of this personnel on base did not hear announcements to move to bunkers or report to medical locations. LRAD announcements were also prefaced by "Attention on Base".

Recommendations: Radios, both FM and Motorola/LMR should be used to push out prowwords. A manual means should also be available to alert the base: an airhorn or siren. The mIRC should also be used to push prowwords. In addition, personnel should echo any prowwords that are announced. BDOC should not use "Attention on Base" before prowwords.

Follow up/Tasking:

ASG-J: LRAD system should be expanded and improved. LMR Radios

SECFOR: Update SOP to include in putting mIRC updates, using LMR radio and manual means as notification PACE plan. In addition BDOC personnel should be trained to use only prowwords and not a preface.

### **Incident Management Phase**

Incident management phase started once "All Clear" was given and ended once accountability was gained.

### **Improvements Needed:**

Observation: Accountability was delayed and difficult to accomplish.

Discussion: Several units did not report in person to the BDOC and runners had to be sent to find them. This delayed accountability and used up BDOC personnel. Other units reported incorrect numbers. Other units had multiple people report accountability with differing reports. In addition the amount of personnel inside the BDOC caused distraction and confusion. Reporting in person had been rehearsed in prior drills.

Recommendations: The senior Soldier, Airman or civilian for each major unit on base must report in person to the BDOC with accurate numbers. This person must report to the Battle Captain and take further instructions from the Battle Captain. No non-essential person should enter the BDOC, if a senior leader reports for accountability they must report, take instructions and then exit.

Follow up/Tasking:

SECFOR: Follow on rehearsal must continue to include reporting in person to BDOC. SOP updated for reporting procedure and posting of a guard (HQ senior leader) to address non-essential personnel inside the BDOC.

Mayors Cell: As discussed in Preparation Phase, an accurate PERSTAT must be established

### Casualty Evacuation Phase

The Casualty Evacuation Phase started once casualties had been identified and ended when all casualties had been moved to the triage site.

#### Sustainment:

Observation: Aid and Litter teams, equipped with litters were directed to the point of impact quickly and moved casualties efficiently in a chaotic, limited visibility environment.

Discussion: Soldiers in the immediate blast site were on scene immediately and started rendering aid and transporting casualties. Soldiers had to dig through rubble to get to casualties. One casualty was thrown on top of a roof. Aid and litter teams arrived shortly afterwards after receiving direction from the BDOC who was able to identify the POI utilizing the Raid camera. Aid and litter teams were able to render aid and transport casualties efficiently. Aid and litter teams had enough litter and personnel to move all casualties. Aid and litter teams located a ladder in the area and were able to move the casualty off the roof in a timely manner. Pre staged litters at the BDOC assisted in quick reaction time. Prior rehearsals prepared Soldiers of where to report, what equipment to gather and where to take casualties. There was little if any confusion with the casualty evacuation plan.

Recommendations: Continue with rehearsals and refinement of casualty evacuation. Continue to stage litters at the BDOC.

Follow up/Tasking:

SECFOR: Plan and prepare for next rehearsal

#### Improvements Needed:

Observation: Equipment could have been pre-staged to assist with evacuation and extraction.

Discussion: Casualties were buried under rubble and thrown on top of buildings. Extraction equipment could have been used to get through rubble and ladders could have been used to move on top of buildings to get to casualties.

Recommendations: Stage ladders and litters at each CCP to assist with evacuation and extraction. Place extraction equipment in a known location for aid and litter teams. Place solar powered lights on CCPs (dedicated CCPs were not used during this incident) Mark cleared CCPs with a green chem light and CCPs with casualties with a red chem light. (dedicated CCPs were not used during this incident)

Follow up/Tasking:

ASG-J: Extraction equipment, extra litters, ladders, Solar powered lights

SECFOR: Stock green and red chem lights with rover vehicles, update SOP for marking CCPs

Observation: Command and control at the point of impact can be refined.

Discussion: The security of the impact site was not established immediately and aid and litter teams bunched on several occasions. In addition, limbs and internals were initially not taken to the appropriate locations.

Recommendations: QRF ensure security of the site and ensure aid and litter teams do not bunch. Stage aid and litter teams outside POI and send in as necessary. Take limbs to Ground Surgical Team (GST) and internal matter to Chaplain.

Follow up/Tasking:

SECFOR: Update SOP with recommendations. Include limb and internal matter transport into next rehearsal.

### Triage Phase

The Triage Phase started when the first patient arrived at the triage location and ended when the last patient was processed out.

#### **Improvements Needed:**

Observation: When being passed from one medical personnel to the next new injuries were found

Discussion: As medical personnel took on new patients new injuries were found that had not been discovered during by the previous personnel.

Recommendations: Each time a patient is handed off a full assessment is completed.

Follow up/Tasking:

Surgeon: Update SOP with recommendations

Observation: Triage location may be too small for all patients or is now compromised

Discussion: Triage location was of sufficient size for the incident but if more casualties were taken an alternate location may have been needed. The deceased were taken into a room out of sight but if there

were more the room would not have been big enough. In addition quad copters were seen during the triage and likely know the location.

Recommendations: Designate alternate and contingency triage location. Provide Chaplain four personnel to move deceased to an alternate location if designated room is not large enough. Food Service personnel should be moved inside while transporting deceased to storage freezer. Use alternate CCP during next rehearsal and for any real-world incident following.

Follow up/Tasking:

SECFOR: Update SOP with recommendations. Plan to use alternate triage site for rehearsal.

Food Service: Ensure LSS workers are moved inside during transport of deceased.

Observation: Not enough MACE trained personnel

Discussion: There were over 50 possible TBIs and there were not enough trained personnel to screen for TBIs. After the screenings, which took nearly all day the medics who were conducting the screenings were found to have TBIs as well.

Recommendations: Ensure anyone who is qualified to screen for TBIs is identified and available.

Follow up/Tasking:

Mayors Cell: Identify personnel trained on TBIs during in processing.

Surgeon: Train additional medical personnel to identify TBIs.

### Treatment Phase

The Treatment Phase started when the first patient was received in the GST and ended when the last patient was moved and or evacuated.

#### Sustains:

Observation: There was sufficient medical and other personnel during the treatment phase, communication was fluid and there was enough blood on hand.

Discussion: During treatment there was enough personnel, medical and otherwise to treat and move casualties. There was a sufficient amount of blood on hand. "Vampire" was called for administrative purposes.

Recommendations: Continue to rehearse current treatment plan to ensure any new personnel are trained and ready. A quantum blood warmer is needed. Personnel are reminded they must wear dog tags at all times. As recommended prior, a full assessment should be completed on all new patients during handoffs.

Follow up/Tasking:

None

**Evacuation Phase**

The Evacuation Phase started upon evacuation identified as been needed and ended when the last patient had been evacuated.

**Improvements Needed:**

Observation: Equipment preparation could be improved.

Discussion: Casualties evacuated to Iraq must have body armor and helmet with them. They would also need a 72 hours bag to sustain themselves. Aid and Litter teams loading casualties onto aircraft need ear and eye protection. There is no phone in the triage location.

Recommendations: Send body armor, helmet and 72 hours bag with any casualty. Ensure all aid and litter teams have ear and eye protection prior to loading casualties. Install a SIPR line in the triage and TMC location.

Follow up/Tasking:

J-6: Install SIPR line in triage location and in TMC.

3. Describe the events from the morning of 28 January 2024 from your perspective to the best of your recollection. Please be as specific as possible.  
I am sleeping in my bed, I wake up to the sound of a small prop motor. I think it's scan eagle and that it's strangely close, I hear the prop rpm increase dramatically and know I have never heard scan eagle do that. I realize it's a drone and that it is most likely not friendly. Remembering previously planning that if this situation were to arise I had planned to roll off my bed onto the floor between my bed and locker and cover my head. I did exactly that, I thought heard the drone fly over our room from the west and knew it was heading towards my buddy's rooms. I heard it impact and then detonate, the sound of debris raining on my roof and hitting the outside walls. The light turns on and I see my roommate t the door. I slip my boots on, ries to open the door but it's blocked by debris. He slams his shoulder into it and it opens enough for us to get out. I step out the door and look left in the direction of the impact. I see one of the buildings is completely gone debris everywhere, figures running past and lots of yelling. I hear "bunker" and follow to the nearest bunker. Once in the bunker I look for and I find them safe. Waiting in the bunker for a few minutes and then meet up in our squad's spot for accountability. We head to the impact zone following behind loose sight o an as they go to look for who unted for. I begin helping clear debris from the walk way and looking for casualties. I bump into ain and we both hear yelling for a ladder. We split ways as we go looking for one. I find one and return with it but by then there has already been two set up and there are people on the roof top working on a casualty. Someone calls for a skedco. Me and Motlagh and one other soldier I'm not familiar with ran to the BAS to get one and return with it. Doc Ski comes over to me and helps open it. Doc Ski decided to swap it for a litter instead and we placed it on the ground next to sgt Rivers torso which had been flung from the building across the walk way and lay under a bench. Me doc Ski and one other soldier I don't recall recognizing lifted his body onto the litter. We called for one more to help carry it and a lot of people came. Some one nudged me out of the way and took my place on the litter. Another sodier brought over a blanket or sheet and I helped lay it over sgt Rivers and they left for the chapel. I stood by for a second and looked to see if anyone needed help. I then began to help move debris and look for more casualties. I then helped a walking wounded move to the chapel. I do not know who they were and I don't recall recognizing them, they were limping and I gave a shoulder to lean on. I met back up with motlagh and depasquale and a few others from the squad. From there I was standing by for instructions. I assisted in moving one casualty from the chapel to the GST and then returned to stand by. I was seen by the medical crew at the BAS, For the remainder of the day I assisted in debris clean up and bio removal.

A6: TF Spartan G39 previously used to do BDOC certification of the various locations. That responsibility was something that the previous 28<sup>th</sup> ID [REDACTED] took on to help fill a training gap. My understanding was there would a tasking that would come out in early FY24 so that TF Spartan G39 would no longer have to take that responsibility and BDOC training would be through the ARTC or an ARTC MTT.

Q7: Are you aware of a 2023 USARCENT tasking order that directs TF Spartan G39 to oversee BDOC training?

A7: There was supposed to have been an official tasking from ARCENT to TF Spartan G39 but to my knowledge it never materialized beyond the draft phase. I reached out to ARCENT to find out when the tasking order would be published. I was informed that it would happen after the start of FY24, post Oct 1, 2024, but i never saw any documentation of the official tasking order.

Q8: But you did say you aware that the 28<sup>th</sup> ID G39 was conducting that training?

A8: Yes they identified a training gap for C-UAS operators and developed a program in hopes that it would be the genesis for a standardized version that CENTCOM/ARCENT would use across the board. The 28th ID provided their SOP and offered [REDACTED] to travel to ARCENT to provide feedback, but no response was ever received to my knowledge.

Q9: Who was the decision maker regarding whether to oversee training and certification of BDOCs in the ARCENT AOR? And specifically at Tower 22?

A9: I made the decision based on potential ARCENT tasking that was going to be published. I sent a team to T22 in SEPT 23

Q10: Did anyone in your headquarters reclama the 2023 tasking order that directed the TF Spartan G39 to oversee BDOC training?

A10: I do not know that.

Q11: You only heard about the training for the BDOC training program from who in 28<sup>th</sup> ID?

A11: [REDACTED] who provided me the details and information. There was a comment that ARCENT G36 through the ARTC would be taking on that responsibility.

Q12: Do you have a copy of the order saying the G36 is taking over the BDOC certification program?

A12: I do not.

Q13: When you say you don't have the bandwidth, how many people does G39 have on the AMD?

A13: I used to have 23. I currently have 22 soldiers. Out of the 22, I have 18 x supporting 24hr operations at 2x Sentinel Radar locations integrated into the Wing Operations Centers and provide Theater Missile Warning (TMW) Operations and Tier II site validations. My 140A is the sole TF Spartan interface control officer. The other 2x Officers have supported various engagements at T22, ASG-K & ASG-J working closely to provide Air Defense support to those locations. Additionally we've supported various other C-UAS engagements, SMEEs, and exercises to meet TF Spartan and ARCENT requirements.

Q14: Do you know around the date when you had the discussion with [REDACTED] about not doing the training?

A14: There was never discussion about not doing the training. Risks about conducting training that wasn't tasked to do.

Q15: Do you recall any conversations with anyone in your chain of command on whether to do the certifications?

A15: I mentioned it to the TFS G3, [REDACTED] and [REDACTED] requesting guidance to proceed or standby for additional guidance, based on information that [REDACTED] provided to them during a meeting in our RIP period.

Q16: What was your understanding as the way forward for the certification program?

A16: The IFRCO MTT would provide training to the operators for the [REDACTED] Further training would need to be completed by trained army personnel that had an understanding of the additional requirements such as the SPINS, AADP, ATO/ACO, etc. The army personnel would provide final feedback to the [REDACTED] who would sign for their team as validated. This would all be done without an official directed task or gunnery type tables.

Q17: How do you train your troops to do that task?

A17: First directing identified troops to start training alongside the outgoing Subject Matter Expert (SME), going through available documentation, ensuring that training plan is developed, capturing lessons learned from the outgoing SME and ensuring troops have an understanding of the necessary task that needs to be completed, ensuring they know where to find the additional products that provides additional documents and requirements.

Q18: Did you ever speak to anyone in the ARCENT G36 about the certification program?

A18: I spoke to ARCENT G39 [REDACTED] about it, expressing the way ahead about an official certification program. I cant recall the rest of the conversation.

Q19: Were you concerned when the trainings didn't happen?

A19: I provided my concerns and sought guidance what I needed to do next to both TF Spartan leadership and ARCENT G39

Q20: Do you think the ARCENT G39 can better train than TF Spartan?

A20: I don't think they can better train, but I think they can help push for an official validation process or help develop a gunnery program to include other services to follow, so that everyone is training and validating under the same standard.

A21: Yes.

A22: To my knowledge, BG Wooldridge, [REDACTED] and [REDACTED]

Q23: What actions, if any, were taken because of [REDACTED] concern for Force Protection, Air Defense and CUAS operations Tower 22?

A23: Raised the [REDACTED] Conducted another site survey in October 2023, attempted to utilize the "Red Team" UAS to validate the [REDACTED] tracking after it was raised but was denied airspace usage by Jordan. Sent my best 14G to provide training and validation to the FAAD operators, utilized [REDACTED] Air Surveillance Academics briefing as part of the training. A Spectrum Manager to check the frequencies and EW capabilities, coordinated for IFRCO MTT training both in September and October 2023. Quickly coordinated for a rapid replacement of the BDOC's FAAD computer in October 2023.

Q24: Did you have any conversations within TF Spartan about requesting more capabilities?

A24: Yes, my team and I had on various occasions with the G3 sections and Command team after many ineffective times the [REDACTED] never detected the Group 1 UASs that flew close to the base perimeter or over their perimeter. Many discussions ensued to include a potential COAs requesting additional C-UAS assets and or other kinetic capabilitie against Group 1 UAS.

Q25: Did anyone from your HQ request additional C-UAS systems?

A25: Yes. [REDACTED] started working in early September 2023 with [REDACTED] from AFCENT C-UAS Division to get the [REDACTED] o T22 as soon as possible. The Ninja was a more reliable system, than the [REDACTED] at the time. Issue we ran into was that it was an AFCENT system, however [REDACTED] worked tirelessly to get it approved as soon as possible. My team & I worked with ARCENT G39 through JTAMD board to get Drone Hunter moved to T22.

Q26: Do you recall you or your team creating a CONOP for [REDACTED] placement?

A26: No. I requested to see if an extra CONUS M-LIDS would be available for TF Spartan to use and send to T22 as a Kinetic capability that included the [REDACTED] radar through ARCENT G39. I was informed that system was the only available system to train CONUS personnel in preparation to take on the mission prior to their deployment to CENTCOM.

Q27: Did you ever make a recommendation to move the TF Spartan owned [REDACTED] ?

A27: Yes. [REDACTED]

[REDACTED] It was/could be used for Red and Green Sands training, potential Kuwait Assurance Mission, and other future partner nation engagements and display shows.

Q28: Do you feel the IFRCO MTT trainers that visit T22 give a sufficient training program to the BDOC Crew?

A28: They are a great source to provide initial training and understanding of the capabilities to personnel that are unfamiliar with C-UAS type operations. That is why i sent my 14G and [REDACTED] to provide the additional green suit portion and assessment of the training, based on initial conversations with T22.

Q29: Is there anything else that you feel we should know?

A29: Tower 22 had issues with Group 1 UAS flying near and on the base perimeter. The Q-50 Multi Mission Radar (MMR) was ineffective for the most part, unable to detect the Group 1 UAS that were flying nearby. This is something that many of my predecessors have voiced in frustration from their experiences, but no one. The Q-50 could be more suitable as a complimentary radar to something more proven such as the KuRFS which is specifically designed to have a more favorable detection capability against the various types of UAS that T22 was experiencing. Early on in the deployment I reached out to ARCENT to see if there was a way to get a KuRFS out to T22, but was told there wasn't enough of those radars available, as CJTF-OIR had most of them due to their operational needs from potential threats and other attacks in their AO.

On various [REDACTED] that were flying above them. The problem persisted and thats when i reached out through the ARCENT C-UAS Synch meeting to get information on a site survey to find out why th [REDACTED] was not having the desired effects. Through this effort I found out that the last site survey of T22 was done in 2021. After getting the necessary data from a JAT analysis, I started coordinating with the G3 to include CEMA and the [REDACTED] to send a team as soon as possible in September 2023 to T22 to help figure out the issues. These efforts contributed to [REDACTED] white paper findings. TF Spartan provided data and story boards from T22 regarding suspected ISR Group 1 UAS through the C2IE database as instructed by ARCENT so that anyone could see trends and could potentially help allocate systems or be the catalyst to help acquire future C-UAS assets to the areas that were having significant UAS activity. This was a hope that someone would see the trend and help us allocate additional capabilities to provide to T22. October 2023 was the first time a Group 2 UAS attempted make a run for T22 while other attempted attacks were happening simultaneously at ATG. Luckily the Q-50 and cross coordination between both sites helped to contribute to T22 FS-LIDS utilizing their EW/PNT to great affects resulting of 1x OWUAS downed outside of T22 perimeter. The information was submitted and communicated for a kinetic defeat system, but nothing was available for OSS. The events of October 7, 2023, initiated a massive AMD surge into theater that provided additional capabilities that were needed, however those assets went to the bases that were higher on CENTCOM CAL. These events allowed to start the move of Drone Hunter, which would help with some type of additional asset to defeat Group 1s but would still require a more power system to defeat Group 2s. TF Spartan C-UAS working group helped get necessary information which contributed to the site assessments and training.

Recommendation way ahead is to start working on CENTCOM/ ARCENT validation program that will ensure the proper approved training program that can develop a gunnery or validation program that can help future TF Spartan units have an approved training plan that can provide the necessary guidance to help BDOC operators understand their roles and responsibilities as well tie in the Air Defense operations piece to soldiers that are not 14 series MOS to understand why its important to further understand other theater requirements and how those requirements are important to Base Defense Operations and C-UAS operations. This will help alleviate confusion and any future issues to ensure the safety of our soldiers.





I immediately yelled out "Bunker" and ran to the bunker myself. After we got the "All Clear" I disseminated my guys to go help out at the impact site and told the CES to head to the Chapel to assist. I myself also headed to the Chapel to assist with carrying litters with injured Soldiers from the Chapel to the GST. After everything settled for a bit, we got another bunker call. We later found out that there was another one way UAS that was either heading our way or toward ATG. It was shot down by ATG. After that, I was assigned to a security detail to guard the bodies of the three killed Soldiers. After about two hours doing that, I was relieved so I could go on shift. I can't remember much while on shift beside having a headache and ringing in my ears with lower back pain. I was only on shift for a few hours that day. 



I ran to the chapel, took a charge of the entryway. I kept the entry way clear, supervised CLS, picked Soldiers for details (Guard Bodies etc.), distributed snacks, water with drip drops, supervised cleaning and mopping of the chapel. An Airforce [REDACTED] brought me his coat ([REDACTED]). I checked in at the BDOC and led a detail to the blast site to help clean. I picked up rubble, personal belongings, and bio material. I took a shift at the BDOC and ate lunch. I fielded calls from TF Sentinel. I was relieved by [REDACTED] at 1500. I went to the ceremony for the bodies, which were loaded on the helicopters. 

A: We have a book in the drawers right next to us for [REDACTED] operators which tells us how to trouble shoot and what steps we need to take. Especially at night when its harder to see we use a heat camera.

8. When were you last trained on the [REDACTED] ?  
A: I can't remember the exact date, but sometime last month. They went over all of the simulators with us and we did it in a real life scenario with a drone to see what it looks like on the system here and how to engage.

9. Are you familiar with the CDS3?  
A: Yes, they brought it here for the training.

A: I'm not sure of their name but they're here on post.

11. Do you feel like you are certified?

12. Do you feel like you are trained Airspace Command and control procedures?

A: I am confident but not certified in it. I'm confident in what I do but I am not fully certified.

13. Did anyone outside of the FSRs come here to validate your airspace control procedures?

Yes, civilians did but not green suiters.

14. What happened at Tower 22 on the morning of 28

A. It was my shift, I started at 2300 like normal. We went to midnight chow at 1230 on a rotational basis. When I go, the right person gets on the FAAD system, and the [redacted] works on the raid system and rotates from there. The only difference is we did the Norwegian ruck march the day before. Other wise it seemed like a normal night. Tower called things up as normal.

I monitor and watch scan eagle come in. The system eventually drops the track because once it gets too low the system can't see it. They diverted the scan eagle because of wind or weather. They looped, went down, and I called safe on deck. I watched them attach the rope to the wing and report it to the RTO and then RTO told the towers that we were safe on deck. 30 seconds to a minute later we heard and felt a big explosion. We ducked, and then hurried up to scan the area. Right away, when they hand mic'd the radio, he heard the explosion through the hand mic. Within seconds of scan eagle landing and the explosion there wasn't any time. There weren't any icons on the system, and the closest one I saw was 4 km out, and maybe another one that was 8-9 km out. Once the explosion happened, I hurried up and scanned the area and could see the area where the one-way UAS exploded. I saw someone get out of the building that exploded. I clicked record a second before that as soon as I could. I saw the explosion area, there was rubble everywhere. I started reporting to the [redacted]. We engaged the PNT from there, and called for bunkers. The [redacted] told the [redacted] to call for bunkers. He had the authorization and was able to call for bunkers and [redacted] wasn't in the room. We acted right away to report everything as soon as possible.

Once bunkers were called, people still ran to help. By like 7 or 8 minutes after we called all clear to get higher ups into the BDOC right away for accountability. Meanwhile, I'm monitoring every single track on the FAAD system and reporting to [redacted]. Towers were reporting lights and also monitoring explosion site. Other than me monitoring operating systems, there was communication all around. I can't remember the exact time but about 30-40 minutes after, ATG reported that theres another one-way UAS. I didn't see anything on the system at all, not on the [redacted]. We still had PNT on for about 53 minutes, more time than recommended by FSRs but we still wanted to make sure that everything was running. I think the coyote downed it, but we're not sure. ATG said it was jammed. Then it got so low it just disappeared after that. I was trying to get eyes on from the night hawk. I was looking around and could see the smoke.

I stayed on shift until 1200 that day and was communicating with the [redacted] and our [redacted] and [redacted] because we had the PNT on for so long that the system was starting to get degraded. I advised to turn it off for 10 minutes to prevent it from overheating or being fully degraded. Leadership agreed. I don't know when we fully went off after alternating every ten minutes. The second one passed ATG, so I assume it went from the north to the south. It was already past ATG by 3-4 km. I don't think the [redacted] picked it up either, but I don't operate that one because I'm focused on the [redacted].

There wasn't much else I could do besides operate the system. Once I got off at 1200, I went to my room, got chow, and got some sleep and then started back up at 2300. After the second one way it was all just operating. I don't remember too much after that.

15. What time did the impact happen?

A. Based off the clock we use, I think it was 0533 when everything happened. I know some of our clocks in the BDOC are faster than others.

16. Are there procedures or battle drills for a "red air" threat or unknown UAS

A. If there is a red track that pops up on the system, from there we will try to ID that track because we want actual visual. I report it to [redacted]. I document height, altitude, and speed. Once I gather all that information, [redacted] will call kingpin and confirm everything with ATG. I let our RTO know direction, azimuth so they can report it to the towers so they can see it for themselves. It does depend on when the base [redacted] can come in. If within 4 minutes, we call bunkers. If within 2 minutes we call incoming. [redacted] has authorization to do that usually, but the [redacted] will also decide. I ID everything, report, and then get guidance from leadership on what else needs to be done.

17. What communication systems do you normally use?

A: I'm right next to the [redacted] so its all just speaking to each other. I don't use any communications systems. Everybody is right there.

18. Are you familiar with PACE?

A. No

19. If the radio system goes

A: SINGAR radios, we have EMBITTIES systems. The [redacted] and [redacted] they all have Motorola radios so if something does happen he has that on his deck. If the radios don't work, then the SOG and [redacted] acts as runners for communications. Same thing with calling bunkers, we have speakers. If it goes down, then we have runners.

A: [REDACTED] our [REDACTED] our RTO, then me and [REDACTED] Leadership comes in and out normally.

21. Who is authorized to call BUNKERS, FRACTURE, FALLEN ANGEL, or VAMPIRE?

a: [REDACTED] is authorized if [REDACTED] or [REDACTED] are not in there. Once they're in there, they have authorization over everyone. Those are the only 3 that have authorization.

22. Can you tell the difference between a ground versus and aerial track?

A: yes, I'm confident to tell what is trash, birds, or aircraft. There are big differences in altitudes, speed, and consistencies in movements. I'm very confident.

23. In relation to here, that night during the attack, do you remember the directions of the tracks that were present?

A: I can't remember. I just remember there was a track that was S/SE that was 3-4 km off and one that was SW 8-9km out.

24. Did you employ any effects as a result of the attack?

A: Yes, I was told by [REDACTED] to engage in PNT and EW (static) within that minute of the blast.

25. Who has delegated authority to active the effects?

A: FAAD operators, so myself. I cannot activate it without the battle captain. He is the lowest level to authorize PNT/EW.

26. What time did you active the effects that night?

A: 0533, within that minute from the time of the explosion. [REDACTED] called bunkers and then told me to go PNT static. Not longer than a minute within that explosion. I activated PNT and EW and then clicked record on the FAAD system as well as the night hawk. The RAID recorder recorded at the exact same time

A: from [REDACTED] From there, it can vary from ATG, or [REDACTED] chat surfer, kingpin, all sorts of multiple sources. But if its an actual threat, he'll receive it from a call

28. Do you recall on that night if anyone received any notification of a probable attack

A: Yes, I believe [REDACTED] received a call. He said that something about Al Rukban is going to get hit. I can't remember exact details, just that they said Al Rukban. It was a 30 minute time frame, which is odd because its usually hours like 24-48 hours. From there, it was out of the notified time frame when we actually got hit. The time frame was 0430-0500 I think. It really doesn't change how our towers work though. We let them know, but they continue to stay vigilant. That night we did contact the towers with the information. [REDACTED] then reported it t [REDACTED], even though we technically weren't specified in that threat. I'm pretty sure that [REDACTED] and [REDACTED] received that information, likely by runner from [REDACTED].

29. Do you remember what time that notification came in?

A: I don't remember. Not sure if it was during our shift brief, but I think it was after our shift brief. It was at least some time before the actual attack happened. I'm not sure where the notification came from. I don't generally ask where the source is from, I'm just pretty sure it was a phone call.

30. When do you think the Scan eagle landed that morning?

A: Scan eagle landed, there was no mistake that it was not a drone. Scan eagle landed at about 0532 or 0533, 20-30 seconds before the explosion. That night I did not record the scan eagle landing although I usually do. Its not a protocol. But I did watch it, called safe on deck, and 20-30 seconds later the explosion happened.

31. Do you know what direction the scan eagle landed?

A: I believe they were monitoring areas from the NE that night, they were going SW. They came from NE, went SW, and had to divert their landing because the wind and their speed at the altitude they were at. I believe they landed on the opposite direction, went from NE to SW diverted and looped around and then landed.

32. Did you know the deceased soldiers?

A: No, they were in a different unit.

33. Are there any products that you can provide us?

A: Unfortunately no. I was in the BDOC the entire time.

34. IS there anyone else we should talk to?

A: [REDACTED] who is not here. He sits right next to me and sees everything as well.

Do you think in the BDOC that you could mark things suspect without any outside confirmation; like you could make that information internally?

I had an understanding we could do it. If it was far away we would go through the proper channels, but if its close then the battle captain would make that decision.

From 0231 to 0235, the track 1051 appears and disappears, the impact happens, and then 2 minutes later you select 1681; can you describe what was happening in between that time?

When I watched scan eagle land, I had the nighthawk on where scan eagle lands and then the explosion happened like 20 seconds afterwards. From there, we just braced and we were trying to figure out what happened. That's when I started sleuthing the nighthawk around.

From 0228Z when you sleuth to scan eagle, and to 0235Z when the impact happened, did you ever sleuth to look at 1060 on the screen?

Once they land, they still have to take it down so I was still looking at the nighthawk.

Is the TTP to look at scan eagle the entire time?

We had an instance where scan eagle crashed maybe a month or so prior and that's when we determined we would watch it land in case of a crash or weather issues

Do you think its possible you missed track 1060 in that 4 minutes because you were watching scan eagle.

Maybe. I just don't remember seeing that track. I for sure didn't see more than 2 tracks in that time before and after scan eagle landed.

Do you think there was a perception at T22 that you would not receive an attack from the south?

I don't think we had a perception that it wouldn't hit from the south. I just know that the most common attacks would come from the north/northeast area. That's why we would have the [REDACTED] pointed in that direction. I personally believe it came from the north because the second one-way came from the north. Most one-ways back to back are launched from the same direction. The systems still didn't even catch that second one, but the coyote was able to catch it. The second one way was definitely coming from the north and ATG saw it. The second one way was 3-4km past ATG. My opinion is that it came from the north.

I don't remember seeing this on the screen. I for sure remember seeing only 2. And once I looked, I was looking at scan eagle and seconds after the land was the explosion. I'm sure I would have seen it if it was coming from the south. Supposedly the drone hit the scan eagle antenna. If it did honestly I would've seen it on the night hawk before it would've hit.

Do you feel like watching the scan eagle might have been a distraction?

Yes tunnel vision is a possibility where I have to watch night hawk and look up at the same time. But [REDACTED] and [REDACTED] also look and they would have let me know. So I could see how, but if I didn't have catch it but I know that other people were looking as well.

Do you recall [REDACTED] or anyone else talking about "look at that track" or "click that track" while you were looking at scan eagle?

No, I don't remember anything like that. If there was a track, I don't remember anyone saying anything. Usually, they would say something. I remember [REDACTED] looking at the green icon on the system while scan eagle was still visible. I can't remember if it came back up as an unknown, but I can't remember [REDACTED]

When scan eagle drops off and pops back up as unknown, do you have to re-mark it?

I usually would go in and unlock it but we won't mark it until we have PID so it can be hard because then we have to get PID on it again. For example, one time they tried 5 times to land, and it kept popping on and off the system. [REDACTED]

What are your thoughts after seeing the tracks we showed you today?

I want to know the distance. Because when we asked ATG and kingpin, they also said there was no track. I get how another system would track it, but how would we know to say that our system tracked it as well [REDACTED]

[Interviewer: Kingpin doesn't see low to the ground, and ATG also wouldn't see on the JTN]

I know we've mentioned multiple times that ATG can see it but we can't see ATG's stuff and I feel like that's setting us up for failure. We have never been hit before this and for one base to only be on one system, its unfortunate with the whole situation. I feel like this is now showing big army that something needed to change. I know [REDACTED] has sent emails requesting more assets prior to this attack. I just don't think our systems caught this and they weren't built for this, specifically for one-ways like this. Now it hit the most vulnerable base [REDACTED]

Is there anything else that we should know?

I feel like this whole story that it came from the north, I believe it came from the north based on what I've seen. It might've come from the south but I just don't think that makes as much sense. There's no way a drone could've hit an antenna and gone off its GPS course. The GPS is going to be accurate and go to its destination no matter what. I know I would have seen it if it came from the south, especially if it hit scan eagle's antenna. [REDACTED]

Can you describe what happened at Tower 22 on the morning of 28 January 2024?

I was sleeping. I woke up to a loud buzzing sound. At first I thought it was scan eagle. As it got louder and louder that it was not scan eagle. It sounded like it flew right over me so from the east like it was getting louder. It could've been the sound reflecting. But it sounded like it came right over my CHU and then hit. Originally when it came in I thought it came from the east or general direction. I don't think it actually came from that way, I think it came from the north based on everything I've seen after the impact. I knew right before the explosion that we were getting hit. I jumped out of bed as the explosion happened and put on my kit and sprinted to the BDOC. I was one of the first people in the BDOC. I think it was around 0530 when I came in based on the wall clock, which is 3 ½ minutes fast. From the time it impacted from the time I was in the BDOC it couldn't have been more than 90 seconds because I always sleep with clothes on. SOP for my role is to not go to bunkers right away, but to go straight to the BDOC. I immediately started inquiring as to why we didn't catch it. I was informed by everyone in the BDOC that there was nothing on any of the systems.

I was informed by my operator, [redacted] that there was nothing on the [redacted] or the FAAD. She's a really good operator. There are two groups that watch the FAAD, so I talked to the guy [redacted]. He goes back in forth in his role but he's also trained on the FAAD and he was right there in front of it and he said there was nothing on the FAAD. I don't recall seeing any tracks on the system. I know I jumped on the system and was looking at it. Nothing immediately stood out to me that I can recall, like if there was clutter or anything. I don't recall seeing any other sort of tracks on the FAAD that would indicate a threat. After that, I looked at where the impact was and it was about 40-50 feet from where the rest of the team lives. So I started trying to get accountability of them and calling it up to higher because I knew we were going to need more assets. We had another bunker call right after we got the entire team inside the BDOC. SOP is to run with the section chief, which is [redacted] and [redacted] I can't say exactly how long it took him to come into the BDOC. Something felt like it took hours but it was only minutes or vice versa. My recollection of time is off. But we kept all our radar operators inside the BDOC, along with our FSR and we ran our battle drill verbatim. We went to bunkers, we got underneath the desks, stuff like that. SOP for us is to stay in the boxes and make sure they're manned. In hindsight, I should've sent two of my operators to the bunkers. There were reasons why I kept them in there. When I tried to send some, they didn't want to go to the bunkers. They wanted to be in the BDOC with the team. We got down under the desks for the next bunker call. Then we got a report that ATG had shot down a one-way with a coyote. After that we just kept up our radar operations, making sure that we were looking for anything else that was going on. Because of the proximity of the impact to certain members of my team, I got them checked for TBIs. One of them has had trouble hearing, and for one there was miscommunication on whether he had a TBI. That's possibly because most of the medics also had TBIs. I'm not sure if my guy had a concussion or not. After that, once things calmed down and triage was over, I left my senior radar operator on the [redacted] system. Then I sent two of my radar operators back to their room, I wanted them to get as much sleep as possible if they could. We still had to maintain 24 hour operations. [redacted] and I went and helped with clean up of the impact sight.

Do you feel that [redacted] has enough training and competence to perform her duties?

Yes. We have never had an incompetence issue out of [redacted] She's really sharp and really good at both sides of the [redacted] system. She's also really good at doing the maintenance and fixing any sort of issues. When we first got here, being national guard none of us do this every single day. Everyone still picked up everything very quickly. I can tell you for certain that there was no competency issue as far as not being able or actually not doing the job. I has absolute faith in the work she does. If she saw something on the radar she would be able to discern the difference of what it is, and the SECFOR people would be able to do it as well. It was adequately manned with people who could identify those things.

Or if its following wind, its probably a balloon. But balloons sometimes register as drones. Even if you can't identify exactly what it is, you can at least identify if its an issue. If its moving between 3-4 m/s it could be a quad copter, but we could tell that.

Did [redacted] or anyone else in the BDOC mention anything about seeing tracks in the south/south west that morning?

No. If they did I don't recall.

Do you work in the BDOC during the daytime hours?

I go in and I work shifts to give my operators time off. So I work every shift a minimum of once a week each.

What are the functions of your role?

I identify tracks. Anything that I see and think is problematic I pass that up to the [redacted] Counter measures are not within our responsibility. So our job is to inform the battle captain as to what we see. We don't control any EW or PNT, we control telling the [redacted] We make sure the network is up and running properly, troubleshooting issues, cataloging any events that happen. All events that happen are notated in the shift log.

Are your roles published in an SOP or other guidance?

Yes and no. It's mainly in the job description. We have SOPs, yes. But the SOP are simply following the duties and guidelines of what a 13R is supposed to do. We may have copies of the SOPs inside of a binder that I can give you. We basically just collect data and pass it up. We basically identify what's going through the air and pass it to the battle captain.

Can you describe any training you have received for your role?

So the training for 13R reclass was about a month long at Fort Hood. We also got trained on the FAAD before we got here. Then we spent the entire rip time training with the previous crew. We've done a lot of hip pocket training learning the ins and outs of the FAAD. Any issues we've had we've contacted [redacted]

Do you run battle drills on your shift?

Yes. Not every day, but every time SECFOR runs battle drills we do it with them. We are deeply integrated with the SECFOR. Days before the attack we ran a battle drill that was eerily similar to the actual attack. It was an incoming, so it was a battle drill involving getting hit with a UAS.

What are the procedures for the red air or unknown UAS?

When we have battle drills, we make them as realistic as we possibly can. As far as our role in the battle drills, we alert the [redacted] that there is an incoming threat and tell him what it is. That kicks off the rest of the drill. As far as what we do internally as a team, whenever there is a UAS sighting we get a lot of information on it from ATG. We then put those in the parameters of what we're looking for, knowing that certain types of UAS travel at different altitudes and understanding how the enemy is using those. I know when ATG got hit and it came in super low, I knew they were going to keep doing that.

Do you feel like the communications between the BDOC here and ATG is good?

Yes

What communications systems do you or your team normally use in the BDOC?

We use the telephones, we've got a NIPR and SIPR phone. Then we've got a SIPR side mIRC chat, we've in all of the mIRC chats.

Are you familiar with the PACE Plan?

Yes.

Do you know the PACE plan for inside the BDOC?

If phones go down. We have a JBCP, they do regular comms checks on those. If phones go down, I know that there are radio assets. However, we don't work with any of those assets. I can't tell you if its up or down right now because I don't use that system but I know they do comms checks with those. That's all I'm aware of. I know we've got the two different lines of phone, two different lines of email, the MIRC chat, and radio assets. As far as communications here, we've got the little walkie talkies, the motorolas.

Does the [REDACTED] system, does that come with SATCOM radios?

[REDACTED] We don't use the shelter trucks. We have them if we have to go into local ops. But mission requirements requires us to stay in the BDOC. Otherwise we would set up those assets.

Who's authorized to call bunkers, fracture, fallen angel, or vampire?

The [REDACTED] is the one responsible for making those calls, so long as it is in the absence of the [REDACTED] or [REDACTED] When either of those two are in, we take orders from them.

So during a night shift, if the [REDACTED] or [REDACTED] are not there, the [REDACTED] is empowered to make those decisions?

Yes

When you went into the BDOC that morning, what did you see on the screens?

I did not see anything that would indicate a threat. I wasn't looking at the entire region, just tower 22.

If the operators were to see something coming from the south/south west, would they think it's a friendly rather than an enemy?

I don't believe the direction of travel of something would bare an indication as to whether something it is a threat in the minds of the operators.

Who has the authority to employ EW or PNT?

The [REDACTED] 100%. I've seen him make that decision. But only in the absence of the base commander or deputy base commander. I've seen it happen more than one time with multiple different [REDACTED] I have observed them doing it without any hesitation or worry over whether they'll get in trouble or anything. The only thing they do before turning it on, they make sure that there aren't any friendly assets that would be impacted.

When [REDACTED] came in that morning, did he have to direct the crew to turn on EW or PNT?

To my recollection, it was already on when I got in there. My memory was that EW systems went active immediately after impact. I don't recall him being in there before me, I think he came in maybe a couple seconds right after I did. However my attention was focused on the [REDACTED] system and the FAAD.

Do you remember [REDACTED] saying anything about PNT once he was in there?

At that point I was focused on doing my job, so I didn't notice anything like that.

How does the BDOC normally receive intelligence notifications of imminent threats?

Phone calls, mIRC chat, any of the communications systems we have. Sometimes its calls, sometimes its in the various chats.

Were you aware of any potential threats in the night leading up to the attack?

I don't recall. We're in and out of threat windows all the time. I don't recall if there was a specific threat window at that time.

Where, from what direction, and when, does the scan eagle land every day?

Other than seeing it fly around on the FAAD. Most of the time it automatically populates green. Sometimes it will fall off the radar and come back on. To my recollection, scan eagle typically lands from the east going west.

Do you feel like the take off and landings are fairly predictable?

No. 2am, 3am, 12pm, any time. I'm not aware of any schedule, the scan eagle flies a lot. I can't tell you when its gonna land or take off.

Did you participate in any AARs after the attack?

Yes. More than one. The official AAR was led by [REDACTED] But there were lots of AARs, [REDACTED] and SECFOR had their own AARs for example. I know that the story board of any event is typically pushed out by [REDACTED] so he probably has the AAR notes.

Did you know any of the three deceased Soldiers?

Yes.

Can you describe your relationship to them?

I hung out with the engineers. I would hang out with SGT Rivers sometimes at the café, sometimes we would eat together. I was in and out of the engineer tent. We would always say hi when we saw each other. We didn't hang out on a regular basis, but sometimes. The other two, Moffett and Sanders, I knew who they were but I didn't know them well.

What was SGT Rivers like?

He was very very Christian. We talked about different things we had done in the army, swapping stories, talking about back home, stuff like that. We joked around too. I know he would come to the MWR and hang out with people, and saw him in the gym from time to time. He was a very open minded and accepting person. So I lead the Norse pagan service on post. Typically for people who are extremely Christian, that makes them uncomfortable but he was accepting of me and everyone.

Did you feel safe at T22? We were always feeling vulnerable since day 1. When ATG got hit, we couldn't see the track. They know we were there and we felt like open targets or sitting ducks. Quad copters will be close by and we don't do anything to them

Do you feel like the [redacted] let people out of bunkers too quickly?

Yes, because from our knowledge and we called fractured so all medical people are out helping. But good thing we did release them because none of the PJs showed up until then.

Can you describe what happened on the morning of 28 January 2024?

It was a normal night. I went to the restroom at 0430 in the morning. I got a text or missed call from [redacted] when I was in the restroom. And then I went back to the BDOC. They said we have a 15-30 minute attack window. They had already informed the towers. Most of the time its just the aircrafts in the air. 30-40 minutes passed by and there was nothing. And around 0520 I had a bad feeling so I walked to my CHU and grabbed my kit. I walked back to the BDOC and I got there at around 0525 based on the wall clock. I sat down in my seat and was looking at the [redacted] I told the towers that the scan eagle from return to base. [redacted] was watching scan eagle, I was watching [redacted]. It landed at 0535 and I called the towers that scan eagle is safe on deck. A couple towers said they heard us. Then one tower, [redacted] or [redacted] and they said that they were confused they didn't think scan eagle landed and then the blast happened. The blast was about 15 seconds after scan eagle landed. [redacted] came in saying "how did you guys not see it" screaming at us, specifically at [redacted] was scared. Then he said the same thing. The [redacted] came in like 30 seconds after the blast happened. First he was asking where it hit and we showed him. He also told [redacted] to call PNT so he turned on PNT. [redacted] told us to call bunkers so we called bunkers. It was really chaotic so I don't totally remember after that.

Can you tell us about any battle drills that you have for red air or unknown UAS?

Normally, we first call the [redacted] for a lot of stuff but we started learning to just de-conflict it ourselves and call kingpin. We were told to just call kingpin if we had any questions. Those were the only instructions we got.

What communications systems do you normally use in the BDOC?

SIPR phone, MIRC chat, and chat surfer. We use radio for contact with all the towers, QRF, and sentinel. When we do radio checks, we do radio first. And if that doesn't work they give us a call on the SIPR line. If that doesn't work, then they'll contact through the chats.

What leadership was present at before and during the attack?

Before the attack, it was just [redacted] and the rest of the BDOC crew. He was the highest ranking person. About 30 seconds after the attack, the [redacted] and [redacted] came in. [redacted] also came in and started screaming like "how did you guys not see that?" And he screamed at [redacted] and kicked her out of the BDOC.

Where were you sitting in the BDOC?

I was sitting right in front of the [redacted] watching it while sitting right next to [redacted] I was looking at the [redacted] right before the attack, and I didn't see anything coming towards us at that time. At some point, I saw two tracks on our south. They were moving really slow and were far away. I can't remember if I saw that before or after the attack. [redacted] is really good and so am I about getting our eyes on every track that comes up. [redacted] was looking at scan eagle using the night hawk. He kept the night hawk on the scan eagle the whole time. He usually clicks on every single track every time. Those two tracks wouldn't have been the one way because they were still like 7km out after we were hit. It was at the edge of our EW circle. There was nothing coming our way or right on top of us. We usually do get stuff right on top of us if there are cars passing through the road. But at the time of the attack, I don't remember seeing anything like that.

What direction do you think the one-way came in on?

I'm assuming it came the same route the scan eagle came in, so like from the Iraq/Syria border.

Do you feel like you dismissed those tracks?

No, we always get eyes on and call it up to the towers. For those two tracks, we got eyes on scan eagle and then the camera went out of whack and then 15 seconds later is when the impact happened.

At any time, did you move the night hawk camera to look at the two tracks in the south west?

No. And then there wasn't time because the impact happened. Then after the impact [redacted] kept looking at all the tracks on the screen.

Based on the speed and altitude of those tracks, you assumed it was something else?

We assumed it was a vehicle, but we still tried to get eyes on it. Most of the time the tower already has eyes on any vehicle. When RTB was called, [redacted] looked at scan eagle for the most part. Those tracks were really far away. I can't remember when exactly I saw those tracks, if it was before or after the impact, I just know it was at the bottom edge of the EW circle.

Can you tell the difference between a ground vs aerial track?

Yes because we look at the altitude and speed.

Did the BDOC team employ any effects as a result of the attack?

The EW and PNT stayed on for 45 minutes after the attack, but it was at the maximum amount of time. It was over loading the system and they started turning it on and off for 10 minute increments.

Who has the authority the C2 or the PNT?

The [redacted] unless we have eyes on it. It was explained to us that PNT is a kinetic effect like taking down something with a coyote so that's why only he has the authority. Battle captain has the authority if its 2km out. By the time anyone would run to the bunkers though, its only 30 seconds so it wouldn't be enough time.

Do you remember what time they turned on EW or PNT?

Maybe 1 or 2 minutes after the impact.

How do you receive intel notifications of a threat?

We usually get a phone call. Sometimes its FBI, kingpin, or ATG.

Did you receive a notification of an attack that night?

Yes, it was around 0440. It was a phone call. The attack was supposed to be within 15-30 minutes from the time of the call. I don't remember there being a chat notification. I just remember having a missed call on my cellphone from [redacted] asking where I was at because I went to the restroom.

What time do you think the scan eagle landed?

0535. It landed about 15 seconds before the attack.

Did you know any of the deceased soldiers?

I knew SGT Rivers, not very personally. I mainly saw him at the gym. I would ask him to spot me a couple of times at the gym.

Are there any products that you could provide that you think would help us?

We did a pretty good AAR after the incident happened. It was about 4 days after it happened. [redacted] hosted it. Everyone who would go for an avengers call went, all the higher ups. The reason we were there was because we were in the BDOC. It was focused on the response of the event. I didn't agree with everything. For example, I called fracture based on the [redacted] direction but some people didn't leave the bunkers because it wasn't all clear. I can also provide screenshots of when [redacted] called and texted me that morning.

Do you think the speakers on base are loud enough for everyone to hear?

No and they aren't connected together so you have to use different mics to reach everyone. There are only two L-RADs, but now only one because the fire fighters sliced through the cable and we lost all CCTV cameras.

Is there anyone else we should talk to?

Just the BDOC crew. I know [redacted] he works on QRF. From where he was at, he was walking out of his room when the blast happened. He wasn't on duty. There's also [redacted] he was on W3 tower that night as part of the SECFOR team. He's currently at JTC.

Is there anything else that you think we should know?

No, I feel like I gave my whole perspective of the night. I don't understand how when we called bunkers, they were only in there for a few minutes tops. But when ATG calls bunkers, they stay in the bunkers for sometimes 6 hours at a time from what we are told. Especially when the second drone came that night, ATG was still in bunkers. We knew it was coming right at all, we couldn't get eyes on but we could see the coyote missile, and we didn't call bunkers until a couple minutes later.

You never selected those two tracks?

No not that I remember. He never took yes off scan eagle so he never clicked off it.

Are you under the impression he would lose the ISR capability if he clicked another track?

Oh no.

Do you know why the other tracks weren't clicked once scan eagle was hooked?

No, I'm not sure.

Is there anything else we should know?

No. I could've sworn I was looking at the radar 30 seconds before the attack and didn't see anything on it. I don't remember seeing anything that was even close to us in our actual AO at that time. When I'm not operating the actual system, I usually look on the left to see the speed and altitude to determine what anything could possibly be. The main thing I looked at was the radar with the altitude and speed.

Do you think that everyone in the BDOC was looking at the Radar and would have seen what you say?

I think so. In the 30 seconds before the impact, \_\_\_\_\_ was looking at the scan eagle. \_\_\_\_\_ was looking too, and he said something about the scan eagle and it popped up as unknown and he asked "hey what's that track right there?" And \_\_\_\_\_ said it was scan eagle but then it disappeared.

Was that track to the south?

I want to say the scan eagle was a little north of us when it disappeared.

But there was no track to the south that disappeared a minute before?

No not that I can remember.

Do you know why \_\_\_\_\_ didn't click on those tracks at that particular time that day?

I don't know his train of thought. I haven't talked to him in weeks. But he would always click on anything that popped up.

Do you think that scan eagle landing was maybe a distraction at the time?

I could see that, yes. I feel like if I was using the FAAD system, I think I would've done the same thing he did. I just don't remember anything coming towards us. We can usually tell when something is moving towards us and we tell \_\_\_\_\_ who would then call King pin and try to deconflict it. When we look at scan eagle when its \_\_\_\_\_ its so small on the system we can't see it until it gets close. So we never assume that something is nothing, but most of the time its trash or something else. It didn't matter if it came from the south or the north, we always clicked everything. We had intel I think a month and a half ago that they moved drones from Iraq to Jordan, so we always paid attention to the whole thing because we didn't trust anyone.

I don't remember that, I was mostly eavesdropping to learn more. Eventually the whole BDOC was brought in. It was more like a qualification for use it.

Did you run through battle drills?  
Yes. We went through scenarios and practiced training on what to do in different scenarios. We did it for day and night circumstances.

How long did that training last?  
They were here close to a week or so, but I don't remember specifics.

We do them about once every two weeks. We get in contact with PJs, GST, QRF, and review the steps in the battle drill and practice scenarios. Every shift had to do it when it happened. There is not an SOP regulating how often we do battle drills.

What happened at Tower 22 on the morning of 28 JAN 2024 while you were on duty?

I got on shift and I talked to the prior [redacted] and received any intel from there shift. We had a shift change brief with the battle captain and asked what need to be accomplished. Afterwards I got chow with some of the guys at the BDOC. Around 0100 there was a house fire at Rukban and we notified the towers. We got eyes on the house fire. An hour later the towers reported that they heard gun fire at Rukban. We could not find the source. Around 0300 or 0400, we were give intel by our [redacted] saying there was a possible incoming attack to ATG. We notified [redacted] right away about the intel. We came back to the BDOC and stayed vigilant. Afterwards at 0530, we saw scan eagle and its tracks fell off Q50. We had eyes on it. We called safe of deck for scan eagle at 0530 and notified the towers. About 30-40 second later, towers called up that they heard a noise. As they were calling it up, we heard a loud boom. I looked at the wall clock and it said 0531. I focused on the raid camera to get ID of where the impact zone was. I heard someone say "call out EW and PNT" but I don't recall who. Afterwards, we called bunkers right away after the impact. About 7 minute later we called clear and fracture. Afterwards, I was waiting for someone from each unit to give me accountability for their groups. I did not see anyone come in. I took the initiative to go towards the blast site to see if I could find someone to give accountability. As I got there, there were people trying to retrieve the body from one of the roofs. I passed up a litter to help out the roof. Then I started looking around for anyone else who needed help. I saw the SOG and we checked in one each other. Then I ran back to the BDOC about 5 or 6 minutes after people started coming in and giving me accountability for their groups. Afterwards, I was giving a battle damage assessment to the BC. Then I was getting numbers from GST and PJs about what's going on, how many they have, KIA and WIA. The reps from each group gave me the wrong numbers, so I called avengers which means leadership comes in to the BDOC and told them that we need to redo the numbers. The second time they gave me the correct numbers. Then I pushed up the timeline and the correct number to th [redacted] and to [redacted]. Afterwards, it was a lot of talking back and forth with leadership to establish timelines. I got replaced by the next shift a few hours after the incident and then I assisted with cleaning up debris. Then I guarded the bodies at the connex for a few minutes until more permanent replacements came along. Then I left and that concluded my day.

When did the attack take place?

0531, a few seconds after the scan eagle landed.

What are the battle drills for "red air" or unknown UAS.

We get eyes on the UAS, notify the surrounding personnel ATG, Kingpin, TPSY and confirm if they see it or have eyes on it. We then notify the [redacted] or [redacted] about the red/hostile tracks. Depending on how far it is, we wait for [redacted] to call bunker or if its closer the battle captain will call bunker.

Describe your battles drills?

I would be either the runner to notify [redacted] if the radio isn't working. I would start a timeline from when they see the tracks and note the speed and altitude. I try to assist with the radio or any of the other systems in the BDOC.

What communication system do you normally?

Radio, SOG will go in person, if he's too far then we will relay the infromation from tower to tower. If none of that is possible, then I will be the runner and notify the tower.

What leadership was present prior to the attack?

Myself and [redacted]. The rest of the BDOC night crew were present, such as [redacted] as the RTO.

Who is authorized to call bunkers, fracture, fallen angel, or vampire?

The [redacted] or [redacted]. Without them, it would be [redacted]. If not him, then I have the authority to call.

Did you observe any tracks on the [redacted] before or during the attack?

I observed 2 when scan eagle landed. They were in the south and pretty far from the location.

Yes, its the difference in altitudes and speeds. We also look at past statistics.

Who activated the PNT and EW and when?

[redacted] but he doesn't have authorization. I remember someone directing him to turn it on. It happened immediately after the attack.

How do you receive intel notifications of imminent threats?


From the MIRC chats or ATG phone call. That night, [redacted] read something from the chat about a possible attack directed at ATG or north/east Jordan and he immediately briefed us on that. I then notified [redacted] immediately and notified the towers over the radio. That occurred around 0300-0400. I don't know of any specified time window or any other details from the intel.

It landed east to west, but they normally do it west to east. This happened due to redirection from weather. It landed at 0530 based on the BDOC wall clock.

Was there anything preventing you from looking at anything else when scan eagle lands?

Usually, we get eyes on scan eagle because about a month before it went down due to winds. So, our internal SOP is to keep eyes on it. We would always look physically and on the radar. I could 100% guarantee you there was only the two tracks on the bottom and then scan eagle.

And no one selected the two tracks on the bottom?

No not that I recall. But I would look back and forth between the different systems.

Do you know why they weren't selected?

No, I'm not sure. I'm assuming because of the distance it was, but that's just my assumption

Do you think 7km is far?

Especially based on how fast they move, I don't think that's far for a one-way.

Was there any reason to disregard the tracks from the southwest?

No we always look 360, that's what I was always taught. We would always still scan south of us, especially when there's intel about a potential attack. There's historical data that attacks have come from the north, so we know they might want to try something new.

Can you confirm if you saw the two tracks before the attack?

Yes, it was before the one-way hit.

I saw two in the bottom left corner and scan eagle. I didn't see the track that's labeled "threat."

7b. Please describe in detail, from your perspective, what happened at T22 on 28 January 2024 from the moment you woke up that morning through the end of your shift that day.  
Answer: I woke up to the explosion and my roommate, [REDACTED] saying my name. At that point we ran from our CHU to find were the first ones out of our rooms in our CHU row. We started screaming bunkers and to get everyone out and in the bunkers in case of another OWUAS attack. We then ran to the bunker nearest our CHU and I made sure the other members of our team, [REDACTED] had made it to the bunker. We stayed in the bunker for 15-30 seconds before deciding to head to our designated place of duty, which is the BDOC during a bunkers call to take over operations. We ran back to our CHU and got shoes and equipment and sprinted to the BDOC. At which time [REDACTED] got ahead of me. To get to the BDOC I had to run directly in front of and beside the impact site.

Upon seeing the impact site I stopped to assess the damage and causalities. Upon seeing the state of the causalities and that medics had begun triage and MASCAL procedures I assessed the place I could be most useful would be in the BDOC at my place of duty to make sure there not more incoming OWUAS. After approximately an hour [redacted] told me to go put on my uniform. I did so and made it back to the BDOC where he then left to put his uniform on and returned. At round 0715L we were informed by ATG that their system had picked up a suspect track which ended up being another hostile UAS. We could not see in the BDOC on our FAAD as the ATG [redacted] is not connected to our JDN network. A couple of hours after that [redacted] came out of [redacted] office and asked the [redacted] if he had a certified POI grid. The [redacted] said that he did not, at which point I informed them that we had a DAGR device in our desk. I retrieved the device from our desk and handed it to [redacted] to go retrieve the grid from the POI. He powered on the device and looked at it for 30-45 seconds before handing it to me and asking if I would like to go retrieve the POI grid and I said yes. He then informed me that battery was low. I put on my Kit and headed to the POI. I arrived there while EOD was in the middle of clearing the site. I approached an EOD member and explained my purpose asking if he would either retrieve the grid for me or escort me to the POI. He escorted me there to the POI, but as I reached it the DAGR battery died. I asked one of the EOD members for the exact grid and they produced it. I then took a note of it and made my way back to the BDOC and passed the information along I stayed on shift until 1345L.

8. Are there any procedures or battle drills for a "Red Air" threat or Unknown UAS? If so, can you describe those procedures or battle drills? Please describe your role in executing those procedures or battle drills.

Answer: The procedure if a [redacted] perator or an [redacted] operator spots and unknown track we get positive identification, at which point Bunkers is called at the [redacted] operators will engage EW / PNT to bring it down. If this drill is enacted no matter where I am myself, [redacted] and [redacted] report to the BDOC when bunkers is called. They would relieve the person on shift at that time. [redacted] takes command of th [redacted] I take command of the FAAD, and [redacted] mans the phone lines.





Can you describe the dates or time frames that you have visited T22?  
The dates are a little hard for me to be precise. In September 4<sup>th</sup>-8<sup>th</sup> 2023 I think. During that visit, I was instructed that we are no longer doing the assessment certification piece from the MTT/IFRCO side. I went back in October and that was the last time I visited since.

What was your understanding of the responsibilities of the TF Spartan G39 Staff Section as it applies to the training, oversight, and certification of BDOCs in the ARCENT AOR?  
As we picked up from the 28<sup>th</sup>, that they had been doing something that wasn't exactly certification but more like an assessment to be signed off by the [REDACTED]. As of July, we were told not to do that because there was not an order to do it. I should also mention that I was under the impression that an order was in the works and we would resume that.

Are you aware of a 2023 USARCENT tasking order that directs TF Spartan G39 to oversee BDOC training?  
The understanding we had from [REDACTED] is that it didn't give us sufficient authority to conduct certifications and that he was assuming risk by continuing the activity. I was under the impression that an order would be forthcoming to give us that authority.

What were your main Force Protection and Counter UAS concerns at Tower 22 following your September 2023 visit to that location?  
I had a lot. Its going to be difficult to list. I wrote about 34 pages of my concerns. Despite the understanding that we weren't conducting the training, I still did what I could to share all of the information I have with the Soldiers in the BDOC.  
I basically shared with them everything that was in the training. But I didn't do it as a formal training because I didn't believe I had the authority to do that and was instructed not to. When arrived at Tower 22, I was first under the impression that they had just ripped into the position. They had a very limited understanding of what was on their screens and the counter-measure

available to them. They seemed unaware of their level of authority to employ their counter measures. Before I went there, T22 had begun to see more group 1 UAS and report more group 1 UAS. During a chief of staff meeting [redacted] specifically asked if he could employ his electronic counter measures. This meeting took place in the [redacted] Conference room at Camp Arifjan. I saw then that they didn't understand the authorities. [redacted] informed him during that meeting that he should engage them.

That meeting was prior to my visit in September, but I can't recall the specific date. I do remember it was near the beginning of a spate of sightings at Tower 22 that ultimately resulted in a large C-UAS working group meeting where General Wooldrige was present to discuss what should be done to engage UAS at T22.

My primary concern when I first met the BDOC team at T22 was the lack of understanding they had of their systems and authority to use their systems. When I explained the scope of a PNT engagement and the authorities associated with its use, [redacted] wanted to retain that authority, likely owing to the scope of its possible effects. I mentioned that for efficiency it should be delegated to a battle captain but understood his rational that he was never far away from the BDOC and would be available to make the necessary decision.

I was also concerned with the functionality of their equipment. During the training the had from the MTT Team in September, The MTT actually red teamed the system. During the first iteration it took them in excess of 10 minutes to locate the target UAV and it was visually acquired by someone on the guard tower. They never aquired it on the [redacted] I moved between the BDOC and the tower from where the pilot was operating the red team UAV so I knew where it was and could see both sides of what was going on.

They flew out a good ways towards Rukban, about 1km or 1.5Km and did an ingress to see if the operators would catch it. After failing to detect the Red Team UAV for some time the Red Team Operator moved it very close to one of the guard towers so they SECFOR would see and report it in order to move forward through the battle drill.

When I went back inside the BDOC I didn't see it on the radar and though the contractors who work with the system assured me that it was there. I didn't think it was there but we progressed with the drill. I was there for the drill with all three shifts. I watched them train the BDOC and would sleep briefly in between shifts to see what they all looked like and I so could speak to all of them. I was disturbed by some of the complacency. I once came in at 0500 and found the [redacted] sleeping. At the time the [redacted] was an [redacted]. I had to wake the guy up to talk to him.

I was also concerned by the physical set up. All of the buildings are thin and pretty tight together and there wasn't any cover or concealment. I thought maybe some physical separation with Twalls would be good. I made some of those recommendations to [redacted] We had a good relationship so I would talk to [redacted] a lot about this. [redacted] response was "I like that idea. Please write it all out for me." I know that he was working several things and implemented light discipline using red lights. Once [redacted] realized he had more freedom to use his countermeasures, they started radiating EW 10 minutes per hour. [redacted] was attempting to mitigate any enemy understanding of his capabilities and possible catch any attempted overflights. I think there was also some lack of confidence in the ability of the [redacted] to detect group 1 UAVs. Also when I arrived, I'm pretty sure neither [redacted] nor the team in the BDOC had a full understanding of the capabilities of the [redacted] system. When I first asked them about whether they had attempted to employ Position Navigation and Timing (PNT) Jamming ,they first asked me what PNT was. But by the time I left [redacted] did have a full understanding.

I think from our conversations that he understood it to be largely effective against groups 1 and 2 UAVs. He did not have a false sense of security, and had a strong sense that he needed something more and understood the gap. I don't want to speak for [redacted], but that was my assessment.

In October, they had improved. When I first went in September I thought they were brand new but I later learned they were rotating back in and they had actually trained initially. In the 3 months that they had rotated out they had forgotten everything. But once I sat down with them, their memories came back pretty quickly. They just failed to remember much of the material after three month of performing other duties. The atrophy in their skills was largely a result of the loss of information that occurred when they trained their replacements, who then lost some of the information over time, and then attempted to re-teach information that was only partially understood in the first place.

What is the relationship between Spartan and Sentinel?

My understanding that Spartan directly owns T22. I think there was a fair amount of confusion in the COMREL. I understood them as a direct reporting unit to Spartan. I'm confident [redacted] was reporting to spartan and not ASG-J. I don't know if he reported to MG Leeney or the Chief of Staff. I understand that ASG-J did not fall in the chain of command. For example, he asked at the chief of staff meeting about his authority under spartan to engage C-UAS. Tower 22 is on the roll call of the Chief of Staff meetings. I have seen the org chart, but I can't remember specifically where Tower 22 was on it but I understood them to report to Spartan. Other units on that slide were TF Thunder, TF Sentinel, TF Reaper, TF Commando, TF Liberty (before they closed down,) Spartan Forward at JTC, and the LNO's from UAE, PSAB, and KWT 22, and then the staff sections down by number and their subsections.

Do you believe that TF Spartan could task Tower 22 or improve their posture?

I don't know the degree to which they could task them. But they certainly made some recommendations to Tower 22.

Do you remember what the unit that was assigned there at the time?

It was Task Force Gunslinger later called TF Sentinel. They ripped in November, so it wasn't the unit that is currently called Sentinel now.

In your best opinion as an Air defense Officer, do you think its best practice to rotate the BDOC crew?

No, and I mentioned the same to [redacted] who also said absolutely not. I asked how we can stop them from doing it. I mentioned it to anyone who would listen. As soon as I learned about it, I realized the rotation was killing their knowledge. They were a stable crew that rotated out and in together. They had lost proficiency in that rotation.

Do you have an understanding of what the pre-deployment C-UAS training was for that crew?

I interviewed all of them on that and got very mixed answer. A couple said that they had training in Texas, but most of them said they had none. I think its possible that most of them did not know they would be in the BDOC until after they arrived. My understanding was that they did not come out here trained.

Did you author a White Paper that explained your issues, concerns, and recommendations for Air Defense and CUAS operations Tower 22?

Yes, I did.

Did you share that with [redacted]

I did. I shared it digitally over email. I think I have a copy of that email. I can look and try to provide a copy. At the time I sent it to only immediate stakeholders because it wasn't quite ready for prime time. [redacted] wanted to see it, and I talked about it with [redacted]. I sent it to [redacted], [redacted] I wanted to get their opinions and develop it to suggest training of OSS personnel through Green Sands.

Did they come out and do a spectrum analysis?

Yes, [redacted] did under our G6. I included it in my paper.

Did you ever voice your concerns directly to the CG or any primary staff, or anyone else in your chain of command?

BG Wooldrigy and I discussed trying to get an [redacted] up there. I know I at least shared with [redacted] and [redacted] and later gave it to [redacted].

I also wrote a CONOP and I had a discussion with [redacted]. I know I've had those discussions, but I can't remember precisely when and with who. But it was a very large topic of discussion at the division in general. The 40th ID staff had an understanding of the issues and concerns and there was a very large C-UAS working group sometime in early September. I brought in storyboards from the G2 to show the escalation. The G2 also did some pattern analysis that captured some potential launch sites but not specifically enough or timely enough that it was anything that could be directly acted on.

My primary concern was that ISR could build into large attacks. At the time, the drone hunter wasn't there yet but I thought that because they were reporting group 1 incursions maybe that piece of equipment was the right one to catch group one UAVs and so maybe they could stop it from growing into a larger attack. In particular I discussed it with [redacted] who after hearing the description of how the Drone Hunter is supposed to operate replied "I want that."

In September, I was not at all confident that the [redacted] was detecting group 1 UAS, not in its placement or its operation. That's what drove me to go back in October. Just before I was scheduled to fly out in October I was informed by the FSRs at T22 that the miltope laptop that controlled the [redacted] had "burned up." I called [redacted] and asked what we could do to get a MILTOPE. We explored a lot of avenues to find out where we could get the appropriate laptop to work with the system and how to get it out to T22. I at the time I felt driven to validate the system so the Drone Hunter could be installed and I was unhappy with what I saw from the FSRs in terms of getting things done to make that happen.

I was already a little biased against the performance of the contractors because when I first did that culminating training event in September they continuously told me that the UAS was on the [redacted] as if I couldn't tell. Finally I broke off and said we'll pull the logs later and re-engage so they could show me the tracks they were claiming the system was detecting. When I ran into one of the contractors later I made [redacted] show me. We went about an hour and half with him pinpointing tracks or EW hits that he claimed were group 1 UAVs being detected by the [redacted] and each time I found the things he was pointing out were not coming from the Q50.

Between my September and October visits I saw an email from [redacted] stating that they had had trouble detecting group 1 UAS too. He stated they updated their software and that solved the problem. So I thought maybe if we update the software that might help. So when we went back, I was very determined that we get the correct Miltope laptop and get the software upgraded to correct the issues I saw in September. There were several failed attempts to find the laptop and get it out to T22. The contractors went up on a convoy to ATG where they were told there was one they could bring back, but somehow still came back without a MILTOPE. Ultimately we determined there was actually one onsite that could be used if the contractors rebuilt the harddrive (reinstalled all of the software). I remember myself and the FAAD FSR, [redacted] spent the next 24 hours or so making sure the [redacted] FSRs had everything they needed and continued to drive forward until the harddrives were rebuilt, the correct software was installed and the system appeared to be fully functional.

During this time I went to the engineers and asked them to make a platform to raise the system high enough to achieve a clear line of site. The Engineers on site were pretty amenable and determined that they could do it with the materials on hand. They didn't do it until after I left only because we would have to take the system offline to move it up and we wanted to check that it was operational first.

Once the Miltop was back up and the software was correctly installed I could immediately see more radar returns, and it as more in line with what I saw on the [REDACTED]. Additionally the IFRCO discovered in the time between my visits that a filter was engaged on the previous installation of the software such that it was not passing group 1 tracks [REDACTED]. With this installation that filter was not engaged. Understanding these changes and seeing the increased detections on the system I couldn't know if the system was 100% but I felt we had gotten somewhere.

I was also confident that the engineers were on task with it getting the radar raised when I left.

Do you feel like the C-UAS systems were functioning properly on 28 January 2024?

It is hard to know. My feelings is that they were. Stuff goes up and down all of the time. The purpose of the October visit was largely to validate the nighthawk camera and the installation [REDACTED]. When I left in October, everything appeared to be working well and they could continue with the installation of Drone Hunter. There is a lot of up and down and routine maintenance with these systems but I'm not aware of any overarching issues.

Did your immediate supervisor [REDACTED] read your white paper?

I know [REDACTED] read it, I just don't know when.

Do you recall discussing your concerns in your white paper with [REDACTED]?

Yes, I talked to [REDACTED] all about it.

Do you recall any actions being taken after you shared the information in your white paper?

Following my return, we discussed T22 with [REDACTED]. I was tasked to create the CONOP for the Drone Hunter and for moving [REDACTED] up to Tower 22. I was also tasked by BG Wooldridge to find the minimum manning required to effectively operate the [REDACTED]. I asked the Contractors this question and also whether they could remote the system into the BDOC thereby reducing the number of Soldiers required to man the system. The contractors avoided answering the question but I persisted in asking until, I believe the IFRCO rep told me four.

Later I got a call from [REDACTED] in which he told me [REDACTED] got a call from the contractors stating I was asking too many questions and that if we didn't stop asking so many questions they were going to assume that we didn't know how to use the system and they would give it to another unit. They were just unhappy about the conversation.

[REDACTED] s with TF Reaper and is being transferred to Sentinel.

It seemed from the COMREL that theoretically TF Spartan could direct the movement of the [REDACTED] but it didn't happen that way in practice. The feeling was that we were not controlling it, but rather we were executing instructions from higher as to where to put it.

Do you believe the issues you identified were a TF Spartan problem or ASG-J problem to fix?

It's a lot like the [REDACTED] in that while they fall on our downtrace, we never had control over where any of the C-UAS asset. The decisions for the distribution of C-UAS assets are tasked to Spartan for execution but I don't believe Spartan does not make those decisions. They were attempting to get a kinetic system up there and I wrote my best stab at a solution to get stuff up there. I have the CONOPs, but I won't be able to directly retrieve the original emails because my email was reprovisioned when I came to JTC and all of my previous emails were lost.

When you were there in the fall, what was your perception of the BDOC in terms of their threat assessment and their feelings of safety generally?

They seemed to feel safe, but were very cognizant of the threat. They were actively looking for UAS, they took it seriously. They did everything they could do with the equipment and training they had to be prepared for any threats that came in to Tower 22. They took it seriously even before Hamas attacked Israel, really in response to things they have seen.

Were there any conversations after the attack at Tower 22 about the work you had done?

[redacted] asked who all I sent my white paper to. But I don't recall anything more.

Is there anything else that we should know?

I think what I see happening now is pretty much what I had written that should happen. Those recommendations that I wrote about seem to be happening now.

I do believe that we've got means of procedural control that we could exercise that we currently are not, such as air space control measure request process by which units send up their Unit Airspace Plans and they come back down graphically in the Air Coordination Order Published on the Tactical Airspace Integration System.

I've seen a lot of material on what happened, and I firmly believe that units publishing their planned use of the airspace and giving that information, graphically represented to the BDOC operators and ADAM Cells would help them differentiate the traffic through procedural identification. I feel like its really low hanging fruit to implement that. It needs to be implemented at the division at TF Spartan. I fought that fight, but they believe it belongs to aviation. I believe that the division should bring their Tactical Airspace Integration System up, and use it, but it can't just be the division. Largely driving that effort would have to be the CAB. At all levels it could be synchronized and that's important because the operators would see where their traffic should be coming from. Who's who in the airspace would be less of a question if procedural controls were in place. Now that they've getting more kinetic assets in OSS, fratricide can happen. Its not just about preventing aircraft accidents, but allowing operators to know who's who by verifying their behaviour and adherence to understood procedural controls. I was told by the aviation section that they don't have the manning to support it. Within the G39, it wasn't our role or function. The officers and NCOs voted on it and I lost.

Do you feel that the training currently conducted by the MTT is sufficient?

No. They don't teach how to operate the system as far as the identification matrix or unit specific ROE or battle drills. They can give guidelines on how to set those things up, but we have to teach how to do that from the green side. Spartan is best positioned to provide that training at Tower 22.

Who owns the combat aviation brigade in theater?

Its under OIR. That's another issue. Air defense for the CAB is owned by OIR. The CAB flies everywhere, but I'm not sure how the geographical comrel boundaries apply to them. I was in the Air Defense and Airspace Management cell at the CAB couple of CABs ago, and they had no interest in running their ADAM cell. Ultimately I communicated with the FAB under OSS to get air picture because no one at OIR was responding to me. I've been an advocate of using all this equipment and fixing these relationships for the past couple of years.

Is there anyone else we should talk to?

The aviators at tower 22 as to what they would like to see happen as far as procedural control. I went to them to talk to them about a user friendly version of the Air Tasking Order (ATO) because the one published by the CAOC difficult for BDOC operators and non aviators to read. I wanted to bring a product back to the BDOC so they could see the traffic to expect for the day and they thought it would be great if a product like that existed and that Spartan should make it. These were the DUSTOFF pilots. I never had a chance to implement that. The operators need the air tasking order in a user friendly format. The Airspace Coordination Order (ACO) graphically represented on the TAIS. The Division Aviation Section sees it as a manning problem. I volunteered to run it because I don't think its that hard. I went as far as to sign it over from [REDACTED] and then they re-visited the idea and said maybe we should vote on it.

Why was there a disagreement?

They believe that function is tasked to aviation to the G32 and G32 at Spartan says they are not manned enough to run it. I offered to just do it myself. I think they believed they would be taking a risk by taking it on, and I disagreed. I figured I could manage it pretty easily, but then I was out voted.

What kind of C-UAS training have you received since you got here?  
Before we got here, there was a drone buster class in Arizona. There was one for [REDACTED] operator in McGregor. Here we received training from the FSRs. It was about 3 or 4 weeks after we got here that we got that training, end of november.

What kind of training did you do?  
We had a lot of questions, so they did a big information presentation for all of us in the BDOC. We got signals on the systems that we didn't know about and after looking into it and were worried that there were quad-copters in the area or the LOMS. The signals were occu-sync and lightbridge. But it possibly has the same frequency as radios in Al Rukban. So we needed a big class on learning those signals and systems. In the middle of that class there was an attack that we weren't sure was meant for us or ATG. With that we were able to activate PNT during the class and run through the whole drill in a real life scenario. They did simulations with us as well.

Did the trainers ever say that you were certified on the training?  
No military personnel, it was just contractors. There was no formal certification.

Can you describe what happened in T22 the morning of 28 JAN 24 while you were on shift?  
 It was a pretty quiet day. We had notification of some gun fire of about 5 shots in Rukban early in the morning and shortly after there was a house fire. Usually every shift checks Rukban for anything suspicious. I don't recall the specific time, its in the [redacted] log in excel, but it was probably around 0200. The wall clock is 4 minutes faster than the computer [redacted] desk which is a different time than the [redacted] desk, and MIRC check has a different time line. Towers were calling up lights which is pretty normal from reapers, civilian airlines, etc. and we deconflict the airspace when we see those. I look at my monitor for the intel chats from chatsurfer/MIRC. Guardian intel collab is one that I monitor, and they posted OSINT intel that said from "Sabereen22 news (not sure of spelling)" with a message that said they were attacking a base near Rukban. It was short and I can't remember it word for word. I put it in our cobra chat. I sent the [redacted] as a runner to tell [redacted] I don't like telling that info on the motorola handhelds because I don't think they're secure. This is also a normal occurrence, we've gotten this info almost word for word in the past. In the past, ATG had been attacked or nothing has been attacked. I don't know how credible Sabereen22 news is. I logged it in my log, and I think it came out around 0330. ATG then called me and passed the same information via phone. ATG said that usually its about 30 minutes after the post that the attack would happen. [redacted] got back, and he confirmed that [redacted] is aware. After that, I made sure everyone was aware and advised. We also notified the SECFOR via the RTO's secure radio. Its a shift SOP that any possibility of attacks that it gets pushed out to the towers. Then nothing happened for about an hour. Scan eagle was advising that they were returning to base and what they were observing, such as a border crossing. We notified towers of the scan eagle's return to base coming somewhere from the north east. I don't recall where they landed from. As they were coming in from the north east, they were in the ATG's [redacted] fan and their track fell off from friendly to unknown. We have an internal night shift SOP to always keep eyes on scan eagle. It landed on the ground at 0530 based on the wall clock, but returned the base around 0500. They flew in circles for awhile before they came in. I told [redacted] to keep eyes on and he was, he PID'ed it as scan eagle. I went back to MIRC chat, monitored for intel reports, and windy to de-conflict balloons and trash which is what I do normally during every shift. The scan eagle went safe on deck, [redacted] confirmed with night hawk that it was safe on deck. I told RTO to relay the safe on deck to the towers. I returned my attention to the MIRC chat to tell everyone that scan eagle is safe on deck. I didn't ever get an opportunity to put that in that chat. Right as I went to type, that's when we got hit. I didn't notice the time. One of the guys at tower keyed up and clicked the mic to say that he heard a noise but was interrupted by the explosion. I told the RTO to yell in the L-RAD bunkers. The next thing I typed in was bunkers. I made the decision for call for bunkers as soon as I heard the explosion. After that, we had to identify the point of impact and found it immediately. The raid camera had been on scan which is an SOP. We identified the point of impact, which was I think CHU YY. It was right in the middle of Tower 22 and the living areas. After that, the whole [redacted] team was here to include [redacted] and [redacted] and [redacted] showed up. Almost all of tower 22 leadership was in the BDOC at that point. I told them all the point of impact and that we have it all on the raid camera. The [redacted] team and [redacted] stayed, [redacted] was in and out a lot. [redacted] was manning the radio to let higher echelon know. We pushed out the point of impact on the radio. I was on the phone with ATG and they had me on speaker with kingpin, but I'm not sure who specifically it was. We were telling them what had happened. From there it was a lot of communication with a lot of people, and a lot of people coming in not sure what to do so I gave them jobs. It got to the point where it was too much and we were getting conflicting information on the MASCAL. [redacted] the company RTO, passed out radios to section heads GST, EOD, SECFOR leadership, incident command [redacted] who took over to impact site. We've had a couple trainings on MASCAL before this incident and this battle drill is included in that training. I asked [redacted] to then stand at the door and to turn away non-essential personnel. At some point, we had that second drone coming towards us and we were told by ATG. I would need to reference the log to know the exact time. I can't remember specific times, but it was around the time [redacted] passed out radio. People were yelling bunkers again. ATG asked us about a "heat source" that they had, and it was nothing that we had on our systems. It doesn't interface with our JDN so we can't see it. At first they thought it was scan eagle but confirmed that it was not scan eagle, they said that it was a drone or something along the lines that told me it was another one-way heading towards tower 22. So at that point we actually did call bunkers again. ATG shot it down with the coyote. We were told to turn the PNT back on and I directed [redacted] to look at the direction and it was north of Tower 22. We picked up the coyote as an unknown track. Dealing with this before, we knew that the coyote was not the one-way. I think he might have seen the explosion from when the coyote shot down the second one-way. I was talking to [redacted] and telling him that one of our PNTs overheated after being on for too long for 45 minutes. [redacted] wanted to keep running it, 10 minutes on 10 minutes off. I should have said something because I thought it was too much. So I told him we were turning it off for now because we lost one PNT and if we lost the other then we would have no defense. We gave an all clear again. After the all clear, we were getting more accurate information regarding KIA and WIA. I was dealing with a lot of higher echelon people calling us. I was putting updates as much as I could in MIRC chat to keep them all advised at once. The timeline is the scan eagle landed at 0530, then the explosion happened seconds later. To me it felt like 30 seconds, but people from the tower said it was more like 5-10 seconds after scan eagle landed. We know it didn't follow scan eagle because the camera was watching it and we were watching it. There was no misconception about that. We never saw the drone, we never saw a track for the drone, the [redacted] didn't show anything. [redacted] immediately after the strike repeated how they didn't have anything on the [redacted] JDN was up during that time. I think the timing was more of a coincidence. It would be really hard to predict because the scan eagle burns off altitude in stamp before it lands. I'm very doubtful that it was following scan eagle, the IRN-16 was more likely to have been following wave points to its point of impact. As for direction, we didn't hear anything and we didn't have any tracks. I can't recall where it was at when I was looking at it. A lot of people in the CHUs say they think it came from the north. EOD and crater analysis also said it came from the north. For those reasons I would say it likely came from the north but I can't say for certain, and we never saw anything on the FAAD.

Do you have battle drills for unknown UAS or red air threat?

Yes. For night shift, we just call on the motorola and report a suspect track and report the facts as to why its suspicious such as its direction, speed, altitude, etc. We also compare it to prior UAS patterns in the AOR from the past to decide if its suspicious. With every second counting, we want to advise leadership at the same time the RTO is notifying the towers. If its coming from farther away, it might go up to the towers first. But if there isn't much time, we'll notify leadership first.

Do you have authorization to call PNT in absence?

Yes, if its within 2 km. I have authorization to call EW.

Are you familiar with PACE?

Yes.

What communications systems do you normally use in the BDOC?

Depends on who we're talking to. If ATG, then we'll call them on SIPR phone. If its something that I just need to contact kingpin about, I'll just call them. If its something I want both of them to know at the same time, I'll put it in the MIRC chat. If its contacting or I usually use motorola or a runner, depending on the type of information because I don't trust the motorola. Contacting sentinel main, we'll use tactical satellite radio.

What leadership was present prior to the attack?

Just the BDOC Crew

Who is authorized to call bunker, fallen angel, fracture, vampire?

I'm authorized to call those. If or is present, they would call it. But I can call it in their absence.

Did you notice any tracks on the FAAD prior to the attack.

The scan eagle track from the NE, and two tracks at the bottom where one was about 10 km and the other was about 5 km away. I don't remember the specifics of their speed and altitude, but the second one was moving slow.

Do you feel like you can tell the difference between a ground versus an aerial track?

Yes, even without or there. Although with vehicles, we've picked them up and they'll be traveling in a straight line for us. Their altitude usually gives away that its a vehicle when its at

Did you employ any effects as a result of the attack?

Yes.

Who authorized to activate the effects?

I said to turn the EW on. I don't recall if I said that for sure but I'm pretty sure I did. was in there within that first minute and told us EW and PNT. He was the one that gave the order for PNT.

How do you receive intel notification of threats?

I monitor chats. I went to ATG's profile and PJs profile. I looked around at other elements to see what they were doing. We also get some emails with intel on them. Chat surfer is usually the way we get most intel.

Did you receive any intel notification of an imminent threat?

Yes, we received a chat surfer message and the ATG called to report the open source intel. From ATG it was that I spoke to that night. I don't recall exactly what time that phone call came in, but they let us know as soon as it was posted.

Did the scan eagle land before or after the impact?

Before.

You said the wall clock is 4 minutes faster than your computer?

Yes. When we made the time line, we were going off of the wall clock. There is a possibility that I read some off my battle captains log in excel and it automatically pastes the time in there so there were probably a few that were in there that was based on the clock that I was taking notes from.

Did you know the deceased Soldiers personally?

No. I'd see them at chow, SGT Rivers was in the gym pretty often.

Are there any other products that you can provide us that relate to anything we discussed from that day?

Yes, my log and chat surfer logs.

Do you feel like you all monitor 360 all the time, or if you saw something to the south you might disregard it?

I would whole heartedly say no. Our shift kind of had a reputation of being "crazy" because we were always saying there was something happening, including the south. So I would say that my shift is the most vigilant. If you talk to \_\_\_\_\_ from scan eagle, we work with \_\_\_\_\_ a lot to figure things out so he would know. So the two tracks that you mentioned in your original statement, and again today, do you believe either of those could have been the UAS that attacked?

I don't think the one to the direct south was because it was 4 m/s of speed. And when the explosion happened, I immediately stood up and looked to the FAAD and both of those two tracks were both in the same place. If there was maybe a third track I didn't see while I was monitoring, I can't rule it out as a possibility. There's just gaps in when I watch the FAAD. \_\_\_\_\_

[redacted] also showed up and assisted I turned back to the explosion and remembered during this time that I had seen someone on the ground. I went to go check on them, that's when I realized it was SPC Moffet, but as I got closer to her it was clear that she was already dead. Someone grabbed me from behind and told me not to look. [redacted] checked her pulse, there was none. [redacted] came and double checked her pulse then put a blanket over her. People were yelling for litters. Once litters arrived they put [redacted] on one and Moffet on the other and carried them away. I saw [redacted] standing near our porch staring into the destruction. I went over to her, when she didn't respond to her name I gently grabbed her face, she looked at me and I told her to get to the chapel. At some point I yelled that are 5 more people that live in this chu. We started digging through the debris. [redacted] told me they took a male to the Chapel but weren't sure who it was. I knew the people in the chu so I asked what he looked like so I could help identify who it was. He said it was a male with a mustache but that described two of the males in the chu. We started looking through the debris [redacted] called he found a body [redacted] and I went over to provide light. [redacted] sked, "what do we got?" [redacted] tarted calling what he could see, I recognized the body as SPC Sanders. She was found on the roof next to her chu, which was the one that was destroyed. Someone called for a ladder and people started to climb up. They put Sanders on a litter and pulled her down. [redacted] was called away by someone behind us. Once Sanders was pulled down, she was examined and determined to be gone. We continued to search. [redacted] remains were found in front of CHU CC. I saw [redacted] one of the Engineers, standing near by and asked him if there was anyone they were missing. He said they couldn't find Rivers. I tried to tell him Rivers was gone but was stumbling over my words. He understood. I told him we found three remains and someone was taken to the Chapel with severe injuries. I asked him to go to the Chapel and get accountability so we could know if we needed to look for more bodies. He came back ten minutes later and reported all the people that lived in the CHU were accounted for. The 3 deceased, [redacted] nd [redacted] had severe injuries and [redacted] who had minor injuries. I told the people digging that everyone in the CHU had been accounted for. [redacted] and I then walked over to the Chapel to assist with aid and litter.




I believe there was a level of neglect by the medical professionals that was not okay. I would like to first point out that they did an outstanding job handling the situation and initial chaos. They saved lives and tended to the critically injured quickly and efficiently. However, in the hours after there were soldiers that were overlooked because others were crying louder. I think the remaining soldiers that lived in the 2 CHUs that were directly in the blast should have been evaluated better [REDACTED] in particular. She was buried under rubble and her roommate was one of critically injured yet [REDACTED] wasn't X-rayed or further evaluated despite telling them she was in pain. Instead she was told that her body pain was to be expected. Instead of being sent out on a later MEDEVAC, she was passed up because she was seen eating ice cream and was told by the doctor she must be fine since she was eating ice cream. She had not eaten anything at all the entire day and was only able to stomach the ice cream. I believe it was extremely unprofessional for a doctor to tell her that and overlook her despite the fact that she was directly in the blast. [REDACTED] was also overlooked despite living in BB1. His squad leader had to fight for him to get sent to JTC to get further evaluated and when he did, it was discovered he had holes in his eardrum. I don't think the location of where soldiers lived was taken into account, or it was likely ignored, because I know there were people that tried to bring it to the attention of leadership.


